Invitation to Bid for Rehabilitation and Minor Improvement of NRJ Sibagat-Esperanza Road (Ilihan Section) (Ref. Code: PW-ADS-13-01)

1. The **Department of the Interior and Local Government (DILG) Regional Office XIII**, through the **Philippines Provincial Road Management Facility (PRMF)** and the **Australian Agency for International Development (AusAID)**, intends to apply the sum of **Six Million Five Hundred Eighty Five Thousand Two Hundred Fifty Eight Pesos and Ninety Five Centavos (Php6,585,258.95)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Rehabilitation and Minor Improvement of NRJ Sibagat-Esperanza Road (Ilihan Section)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The DILG Regional Office XIII now invites bids for the **Rehabilitation and Minor Improvement of the NRJ Sibagat-Esperanza Road (Ilihan Section) (3.22 kms.)**. The Project will involve earthworks, preparation of sub-base and surface/base courses, drainage works, and provision of culverts with miscellaneous structures for the Rehabilitation Component; and machine and/or manual patching of unpaved road surface, cleaning of drainage, vegetation control and traffic maintenance for the Maintenance Component. Completion of the Works is required within **200 Calendar days for the Rehabilitation Component plus 365 calendar days for the Maintenance Component**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary *pass/fail* criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", with some exceptions/amendments as stipulated in the approved Memorandum of Subsidiary Arrangement (MSA) between the Government of the Philippines (GOP), thru the DILG, and the Government of Australia (GOA).
4. Interested bidders may obtain further information from the Special Bids and Award Committee (SBAC) and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m. during work days.
5. A complete set of Bidding Documents in CD format (soft copy) may be secured free of charge by interested Bidders from the address below. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity.
6. The DILG Regional Office XIII SBAC will hold a Pre-Bid Conference on 22 January 2014, 9:30 a.m. at the LGRRRC, DILG Regional Office XIII (CARAGA), 1559 JC. Aquino Avenue, Km. 4, Libertad, Butuan City, which shall be open to all interested parties.

7. Bids must be delivered on the address below on or before 04 February 2014, 9:00 a.m. All bids must be accompanied by a bid security in any of the acceptable forms and amount, or a Bid Securing Declaration as stated in **ITB Clause 18.3**.
8. Bids will be opened on 04 February 2014, 9:30 a.m. at the LGRRC, DILG Regional Office XIII, 1559 JC. Aquino Avenue, Km. 4, Libertad, Butuan City, in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.
9. The DILG Regional Office XIII reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
