REQUEST FOR QUOTATION SMALL VALUE PROCUREMENT OF GOODS AND SERVICES

RFQ No. 2015-014

The Department of the Interior and Local Government - Region 13 (DILG-13), through its Bids and Awards Committee (BAC), invites interested suppliers to submit their quotation for Catering Services during the conduct of Trainings on Community-Based Disaster Risk Reduction and Management (CBDRRM) for Barangay Disaster Risk Reduction and Management Councils (BDRRMCs) of Selected Barangays in Dinagat Islands with an Approved Budget for the Contract (ABC) of Two Hundred Ninety-Seven Thousand Pesos Only (P297,000. 00) which the entity will procure through Small Value Procurement in accordance with 53.9 of the Implementing Rules and Regulations of Republic Act No. 9184.

Deliverables:

A. LOCATION
