4 BAC Resolution Recommending Award No. 2019-017 5 March 27, 2019 RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE 6 AWARD FOR THE PROCUREMENT OF MEALS AND ACCOMMODATION FOR THE 7 CONDUCT OF BNEO JUMPSTARTING LOCAL GOVERNANCE: PLANNING FOR 8 DEVELOPMENT ON MARCH 28-29, 2019 AT THE CONTRACT PRICE OF PhP174,225.00 9 10 WHEREAS, the Department of the Interior and Local Government Regional Office XIII has an approved budget for the contract of One Hundred Seventy Four Thousand Two Hundred 11 Twenty Five Pesos (Php174,225.00) for the above activity; 12 13 WHEREAS, upon request of the conduct of the activity, the BAC posted in the PHILGEPS, agency website and bulletin board the Request for Quotation for the activity; 14 15 WHEREAS, in response to the request, the following service providers submitted their quotations as follows: a.) Butuan Grand Palace Hotel Php174,225.00 b.) Hotel Oazis 16 Php224,500.00 c.) VCDU Prince Hotel Inc. Php144,400.00 d.) Almont Inland with no quotations 17 18 made; 19 WHEREAS, VCDU Prince Hotel has the lowest offering however, said establishment has been found to be unresponsive to the required conditions; 1.) Not amenable to room sharing of 20 2-3 persons in a room as stated in the RFQ 2.) The Pax will be billeted at VCDU Montilla Blvd. 21 22 while the venue for the convention will be in VCDU Villakananga; 23 WHEREAS, the BAC declared Almont Inland, Hotel Oazis, and VCDU Prince Hotel Inc. 24 disqualified due to unresponsive quotation; 25 WHEREAS, the BAC declared Butuan Grand Palace Hotel to have given the Lowest 26 Calculated and Responsive Quotation most advantageous to the government; 27 WHEREAS, upon unanimous vote, the BAC hereby recommends to Ms. Lilibeth A. Famacion, Regional Director, Head of the Procuring Entity, to award the above contract to 28 29 Butuan Grand Palace Hotel and issue the corresponding Notice of Award.
