**RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE
AWARD FOR THE PROCUREMENT OF MEALS AND ACCOMMODATION FOR THE
CONDUCT OF INTEGRITY CIRCLE CUM PRE-RETIREMENT SEMINAR ON MAY 9-10, 2019
AT THE CONTRACT PRICE OF PhP294,000.00**

WHEREAS, the Department of the Interior and Local Government Regional Office XIII has an approved budget for the contract of Three Hundred Ninety Nine Thousand Pesos (Php399,000.00) for the above activity;

WHEREAS, upon request of the conduct of the activity, the BAC posted in the PHILGEPS, agency website and bulletin board the Request for Quotation for the activity;

WHEREAS, in response to the request, the following service providers submitted their quotations as follows: a.) Gazebo Pools and Restaurants Php210,000.00 b.) Kimberly Beach Resort and Veranda Beach Resort with no quotations made c.) Amontay Beach Resort Php294,000.00;

WHEREAS, Gazebo Pools and Restaurants has the lowest financial offering, however the room accommodation is dormitory type with 10 pax per room found to be unresponsive to the required conditions in the RFQ;

WHEREAS, the BAC declared Gazebo Pools and Restaurants, Kimberly Beach Resort and Veranda Beach Resort disqualified due to unresponsive quotation;

WHEREAS, the BAC declared Amontay Beach Resort to have given the **Lowest Calculated and Responsive Quotation** most advantageous to the government;

WHEREAS, upon unanimous vote, the BAC hereby recommends to Ms. Lilibeth A. Famacion, Regional Director, Head of the Procuring Entity, to award the above contract to Amontay Beach Resort and issue the corresponding Notice of Award.
