RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD FOR THE PROCUREMENT OF MEALS AND ACCOMMODATION FOR THE CONDUCT OF STRENGTHENING INSTITUTIONAL CAPACITY ON RBME FOR CARAGA PROVINCES ON SEPTEMBER 23-27, 2019 AT THE CONTRACT PRICE OF PhP434,745.00
