Butuan Grand Palace Hotel Php83,300.00 b.) Balanghai Hotel 17 18 Php88,300.00 c.) VCDU Prince Hotel Inc. Php73,140.00 d.) Almont Inland Resort with no quotations made; 19 20 WHEREAS, VCDU Prince Hotel has the lowest offering however, said establishment has 21 been found to be unresponsive to the required conditions; 1.) Not amenable to room sharing of 2-3 persons in a room as stated in the RFQ 2.) The Pax will be billeted at VCDU Montilla Blvd. 22 23 while the venue for the convention will be in VCDU Villakananga; 24 WHEREAS, the BAC declared Almont Inland Resort, Balanghai Hotel, and VCDU Prince 25 Hotel Inc. disqualified due to unresponsive quotation; WHEREAS, the BAC declared Butuan Grand Palace Hotel to have given the Lowest 26 Calculated and Responsive Quotation most advantageous to the government; 27 28 WHEREAS, upon unanimous vote, the BAC hereby recommends to Ms. Lilibeth A.
