## REQUEST FOR QUOTATION

The Department of the Interior and Local Government - Region 13 (DILG-13), through its Bids and Awards Committee (BAC), will undertake a Small Value Procurement for the Renovation of Agencia Española de Cooperacion International para el Desarollo (AECID) Caraga Regional Office, D & V Plaza Bldg., J.C. Aquino Avenue, Butuan City, in accordance with Section 53.9 of the Implementing Rules and Regulations of Republic Act No. 9184. Approved Budget for the Contract: Two Hundred Thousand Pesos (P200,000.00); Contract Duration: 30 days from receipt of Purchase Order.

Prospective bidders shall accomplish, provide correct and accurate information and submit the following: (i) List of on-going and completed contract together with one (1) sample design for similar contracts; and (ii) Price Quotation Form duly signed by the authorized signatory (Annex "A")

Submission shall be not later than 5:00 p.m. on \_\_\_\_\_\_\_, 2012. Open quotations may be submitted, manually or through facsimile at DILG Regional Office 13, Libertad, Butuan City, Tele/Fax No. 342-2134 or 815-1299.

Price quotation/s must be valid for a period of thirty (30) calendar days from the date of submission. Award of contract shall be made to the lowest quotation which complies with the minimum technical specifications and other terms and conditions stated herein.

The DILG 13 shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.

Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by the bidder or his/her duly authorized representative/s.

Liquidated damages equivalent to one tenth of one percent (0.001%) of the value of the deliverables not delivered within the prescribed period shall be imposed per day of delay.

The DILG 13 shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.

The DILG 13 reserves the right to accept or reject any or all quotations and to impose additional terms and conditions as it may deem proper.
