Calculated and Responsive Quotation most advantageous to the government;

WHEREAS, upon unanimous vote, the BAC hereby recommends to Ms. Lilibeth A.
Famacion, Regional Director, Head of the Procuring Entity, to award the above contract to
Almont Hotel and Inland Resort and issue the corresponding Notice of Award.
