**RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE  
AWARD FOR MEALS AND ACCOMMODATION FOR THE CONDUCT OF ORIENTATION ON  
THE HARMONIZATION OF THE LOCAL PLANNING PROCESS AND BUDGETING SYSTEM  
FOR LGSF-AM PROGRAM IMPLEMENTERS ON NOVEMBER 6-8, 2018 AT THE CONTRACT  
PRICE OF PhP116,130.00**

WHEREAS, the Department of the Interior and Local Government Regional Office XIII has an approved budget for the contract of One Hundred Forty Four Thousand Two Hundred Fifty Pesos (Php144,200.00) for the above activity;

WHEREAS, upon request of the conduct of the activity, the BAC posted in the PHILGEPSS, agency website and bulletin board the Request for Quotation for the activity;

WHEREAS, in response to the request, the following service providers submitted their quotations as follows: a.) Hotel Oasis Php143,640.00 b.) Butuan Grand Palace Hotel Php144,200.00 c.) Balanghais Hotel with no quotation submitted d.) VCDU Prince Hotel Inc. Php116,130.00;

WHEREAS, the BAC declared Butuan Grand Palace Hotel, Hotel Oasis and Balanghais Hotel disqualified due to unresponsive quotation;

WHEREAS, the BAC declared VCDU Prince Hotel Inc. to have given the **Lowest Calculated and Responsive Quotation** most advantageous to the government;


WHEREAS, upon unanimous vote, the BAC hereby recommends to Ms. Lilibeth A. Famacion, Regional Director, Head of the Procuring Entity, to award the above contract to VCDU Prince Hotel Inc. and issue the corresponding Notice of Award.
