WHEREAS, in response to the request, the following service providers submitted their quotations as follows: a.) Butuan Grand Palace Hotel Php803,810.00 b.) Hotel Oazis Php819,650.00 c.) Almont Inland Resort Php880,250.00 d.) Balanghai Hotel & Convention Center Php805,600.00;

WHEREAS, the BAC declared Hotel Oazis, Balanghai Hotel and Convention Center and 21 Almont Inland Resort and Convention Center disqualified due to unresponsive quotation; 22

WHEREAS, the BAC declared Butuan Grand Palace Hotel to have given the Lowest Calculated and Responsive Quotation most advantageous to the government;

WHEREAS, upon unanimous vote, the BAC hereby recommends to Ms. Lilibeth A. Famacion, Regional Director, Head of the Procuring Entity, to award the above contract to Butuan Grand Palace Hotel and issue the corresponding Notice of Award.
