- Sparklers
- Luces
- Fountain

- Mabuhay
- Roman Candle
- Trompillo
- Airwolf
- Whistle Device
- Butterfly
- All kinds of pyrotechnic devices (pailaw)
- Other types equivalent to foregoing devices



2013 CARAGA LGU REGULATION OF FIRECRACKERS AND OTHER PYROTECHNIC DEVICES

In line with Republic Act No. 7183, DILG-Memorandum Circular No. 2010-148 dated December 14, 2010 calls for all Local Government Units in all levels to regulate the sale, manufacture, distribution and use of firecrackers, polyvinyl Pipe "Boga" and other Pyrotechnic Devices.

INDICATORS AND THEIR MEANINGS

The five indicators are defined in MC 2010-148 are as follows:

Ordinances Issued—MC
2010-148 called for LGUs to
enact an ordinance, as may
be necessary or if justified,
totally prohibiting the manufacture, sale, distribution and use
of any firecracker and pyrotechnic devices, if there is
reasonable ground to believe
that radical groups may take
advantage of the holiday season's merriment for their lawless designs, and promote an
alternative revelry.

Designated Zones— The same MC called for LGUs to establish "Fire and Pyrotechnic Zones" in their localities, to serve as designated areas where people may sell firecrackers and pyrotechnic devices; and to designate an area where people may use said firecrackers and pyrotechnic devices.

Information Campaigns—

LGUs are also asked to take the lead in the conduct of an information campaign on the dangers of these devices; Local Peace and Order

Councils— LGUs are likewise asked to convene their Peace and Order Councils or Committees in order to incorporate in the Public Safety Plans a specific project aimed at protecting their constituents.
