Raising the Bar of Excellence

ur call for public service has a much greater calling nowadays. It creates a demand that we need to address immediately. So many pressing issues have emerged which needs attention and solution. A lot of times, we are bombarded with work that there are already so much things needed to be done in just a matter of time. Taking a quick glance of where we are right now and asking ourselves what have we done so far in our years of service would lead us to know if we have done our best in our line of work.

The Department has been implementing good governance projects to improve the lives of the community as well as alleviate their existing conditions. The government is moving millions of pesos as worth of projects for the provision of basic services and other developmental needs. People participation is now highly encouraged so as to empower and mobilize them. It has created a demand for proposing projects which they identify to address their sectoral concerns. This has been answered by the Bottom-up Budgeting (BuB).

Local Government Units have been subjected to certain policies and rules in the implementation of government programs. A measure of its performance can be gauged through the Seal of Good Local Governance (SGLG). The conferment of the Seal will only be given to LGUs that adheres to the following performance criteria: good financial housekeeping, disaster preparedness, social protection for the basic sector, business-friendliness and competitiveness, environmental management, and law and order and public safety.

Conflict-affected areas are also provided with government interventions such as the Payapa at Masaganang Pamayanan (PAMANA) and rebel or armed groups are encouraged to go back to their communities through the Comprehensive Local Integration Program (CLIP).

Waterless communities are provided with potable water systems through the Sagana at Ligtas na Tubig Para sa Lahat (SALINTUBIG) and remote areas are provided with local access roads.

Those are just few of the programs our Department has been implementing. The road to progress is never easy. If we are to ask the community if they are satisfied on what we have done so far and their answer is "yes", then we can say that we have done enough. But if their answer is "no", then maybe what we think is enough is not yet enough. We still have to do more than what we have already given and more than what we have already achieved. This means we need to raise the bar of excellence.

In the eyes of the people, we need to see that they are satisfied. In their existing conditions, we need to feel that they are well-served.

For a fact, there were many challenges and bumpy roads along the way but we somehow managed to push through. Together with the DILG 13 personnel, we highly encourage local government units to work with us in improving lives and uplifting the conditions of the community. We strongly push for good governance. Assessment Year 2014

Assessment Report

For a Local Government to be conferred the Seal of Good Local Governance (SGLG), it needs to pass the three (3) core assessment areas and at least one (1) essential area, dubbed as "3 plus 1" principle.

The three (3) core areas are Good Financial Housekeeping, Disaster Preparedness and Social Protection, while the three (3) essential areas are Peace and Order, Environmental Management and Business-Friendliness and Competitiveness.




The 2014 Seal of Good Local Governance Assessment Result reveals that there is more that need to be done, governance challenges that need to be hurdled and national laws that need to be strictly complied with by our provinces, cities and municipalities.

In Caraga Region, on a general trend, among the three core assessment areas – most of the LGUs are doing well in Good Financial Housekeeping while a good number are found to be disaster prepared. Alarmingly, most LGUs need to improve on Social Protection area.

Meanwhile, in the essential assessment areas, almost all of the LGUs show good performance in Peace and Order, majority of LGUs hurdled the criteria on environmental management and business friendliness. While all provinces and all cities passed business-friendliness and a majority passed environmental management, there were more municipalities that passed environmental management than business friendliness.

The inclusion of these identified assessment areas in SGLG are considered to ensure that the desired governance conditions for the LGUs are attained.





The indicators wherein LGUs can improve much on are on Maternal Care Packages (45% of Cities and Municipalities); compliance with accessibility law (80% of provinces and only 3% of Cities and Municipalities); and LGU-managed youth homes/bahay pagasa or any similar care facility (4% of Cities and Municipalities).

Disaster Preparedness



In the Disaster Preparedness Criterion, Assessment Results reveal that although all provinces and cities passed, only 42 out of 67 Municipalities passed.

DILG 13 conducts Regional Strat-Plan Workshop on Mainstreaming CCA & DRR in Local Development Planning

Regional Strategic Planning Workshop on Mainstreaming CCA and DRR in Local Development Planning

Regional Line Agencies (RLAs), Local Resource Institutes (LRIs) and Civil Society Organizations (CSOs) involved in CCA and DRR Mainstreaming in Local Development Planning were invited for a Strategic Planning Workshop and came-up with a list of technical assistance and services for the mainstreaming process.

Regional Strategic Planning Workshop on Mainstreaming Climate Change Adaptation (CCA) and Disaster Risk Reduction (DRR) in Local Development Planning was conducted by the DILG Regional Office 13 (Caraga) on September 30, 2015 at Pietros Square, Capitol Bonbon Road, Butuan City.

The activity gathered Regional Line Agencies (RLAs), Local Resource Institutes (LRIs) and Civil Society Organizations (CSOs) in the region that are involved in the mainstreaming process. They were oriented on the policies on mainstreaming as embodied in DILG Memorandum Circular No. 2015-77 and in its implementation strategies.

To ensure that the mainstreaming process be carried out effectively, a call for the creation of a Regional Composite Team (RCT) under the Sectoral Committee on Environment of the Multi-Stakeholders Advisory Council (MSAC) is needed. The participants responded positively to this call and thereby agreed to become members of the RCT. The creation of the RCT will be done through a Resolution of the MSAC, which is now for approval and adoption.

A Planning-Workshop was conducted to identify what technical assistance and services the RLAs, LRIs and CSOs can provide to local government units to mainstream CCA and DRR in their Comprehensive Land Use and Comprehensive Development Plans.

The participants identified areas of convergence and /or collaboration for the mainstreaming process. The activity ended with an action planning, which includes the conduct of Advocacy and Information Campaign on Mainstreaming CCA and DRR in Local Development Planning to LGUs along the Agusan River Basin (ARB) And in the Eastern Seaboard (ES).

ESSENTIAL AREAS

Peace and Order



Among the essential elements, peace and order seems to be the criterion where most LGUs have excelled on. All provinces and cities have complied with all four indicators while all municipalities have passed the indicators on Anti-criminality action plan adoption; and logistical and financial support provision to local police stations; and 94% municipalities passed the indicators on having local peace and order councils convened; and support provided for the organization of the Barangay Peace Action Teams, or its equivalent

Business-Friendliness and Competitiveness



On the matter of business friendliness, all provinces have designated LEIPO Officers. For the case of cities and municipalities, cities seem to have performed better in this aspect with all cities having setup their database or recording system for local business and 83% of cities have designated LEIPO officers; complied with standards of simplified business processing and licensing; and among the top 50 on the competitiveness index of the National Competitiveness Council.

Environmental Management



In Environmental Management, only 3 out of 5 provinces have their 10-year Solid Waste Management Plan. And contrary to the business friendliness criterion, municipalities in this criterion seem to have performed better than cities.







Meet the New Secretary of the Interior and Local Government

SILG Mel Senen S. Sarmiento

el Senen Sarmiento is the newly-appointed Secretary of the Department of the Interior and Local Government (DILG). Prior to his appointment, he was on his second term as representative of the 1st District of Samar.

He is the principal author of the Strengthened Anti-Trafficking in Persons Act. He also authored Republic Act No. 10630 which strengthened the Juvenile Justice and Welfare Act. In this Congress, he headed the House Delegation to the Commission on Appointments. He was also the Chairman of the Joint Congressional Oversight Committee on the Automated Elections System.

As Western Samar representative, he filed a total of 48 house bills, co-authored 157 bills, and delivered 12 privilege speeches. Before becoming a member of the House of Representatives, he was Vice Mayor of Calbayog City from 1992 to 1995. It was during his term that Calbayog City became the Cleanest and 2nd Most Peaceful City in the Philippines.

He was then elected as City Mayor of Calbayog in 2001 until he termed out in 2010. During his term as mayor, he also served as the Secretary General of the League of Cities for two consecutive terms and was also the Chairperson of the Regional Development Council – Region 8.

Calbayog City, during his term received numerous awards for effective and participatory governance, some of which are the following:

- ⇒ 2003 Gawad Kagalingan Award;
- ⇒ 2003 Best Practices Award;
- ⇒ 2004 2nd Placer, National Search for Model Barangay Eco-Waste Management System;
- ⇒ 2004 Galing Pook Award;
- ⇒ Presidential Medal of Merit;
- ⇒ 2006 Gawad Saka Award for Outstanding City Agriculture & Fishery Council;
- \Rightarrow 2007 Konrad Adenauer Medal of Excellence; and
- ⇒ 2008 Competitive City Award.

It was also during his term as local chief executive when Calbayog City was identified as the city with the highest reduction in poverty incidence according to the National Statistical Coordination Board.

The Department recognizes local government units' internal housekeeping by establishing the Performance Challenge Fund (PCF) as an incentive for excelling good local governance performance. Since 2010, about 99% of Caraga LGUs accessed the fund.

To address the performance gap in the implementation of PCF-supported projects especially in terms of complying to required documentary reports subject to Audit by COA, the regional office convened the DILG and LGU Officers for said purpose.

The activity addressed several issues and concerns in physical and financial reportage on the completed and ongoing PCF-supported projects in the region, as well as establishing uniform understanding among core players on the Operational Guidelines and mechanics of project management of the PCF.

To capacitate LGUs in the crafting of their Local Climate Change Action Plans that is customized according to its exposure and vulnerability, the Department of the Interior and Government (DILG) Region 13 (Caraga) conducted a Training on Vulnerability and Adaptation Assessment for the Formulation of Local Climate Adaptation Change (LCCAP) on September 1-3, 2015 (Batch 1) and September 8-10, 2015 (Batch 2).

The Plan will serve as the blueprint for future land use and will guide the LGU on tasks perform in reducing vulnerability and improving resiliency. It will spell out programs, policies and activities in mitigating and adapting to climate change which will be integrated in their development plans.

The participants for the training were the Municipal Local Government Operations Officers (MLGOOs), Municipal Risk Reduction and Disaster

in climate change Officers respective areas and Municipal determine what possible and Planning and Development strategic actions are to be (MPDCs), taken in order to decrease Municipal Environment and vulnerability and increase resiliency.

For Batch 1, the LGUs invited were the Municipalities of Pilar, San Benito, San Isidro, Socorro, Sta. Monica, Dapa, Del Carmen and General Luna of the Province of Surigao del Norte. It also included participants from the City of Butuan. For Batch 2, the Municipalities of Carmen, Jabonga, Kitcharao, Magallanes and Santiago of the Province of Agusan del Norte were invited. It was also participated by the Municipalities of Cagdianao and San Jose of the Province of Dinagat Islands, and Cortes of the Province of Surigao del Sur.

The Regional Consultative Conference and Orientation on the Road Board's newly revised Guidelines on the Implementation of Projects under the Special Local Road Fund (SLRF) was conducted last August 14, 2015 at Pietros Square, Capitol Bonbon Road, Butuan City.

A total of 50 were in attendance, comprising of 14 Engineers and 9 Accountants and 5 others (e.g. LTTMO, CPDO, etc.) from the 11 LGUs, i.e. 5 provinces and 6 cities; 2 DPWH XIII (Engineer personnel Accountant); 3 COA Auditors assigned to DILG and DPWH; 5 DILG Provincial Focal Persons; 9 DILG Regional Office personnel; and the 3 OPDS-SLRF facilitators/ resource speakers.

The participants appreciated the presence of DPWH and COA representatives with whom they were able to air concerns or clarify procedures especially in terms of reportage/liquidation. By LGOO II Naomi C. Oroq **Training** Geographic Information System (GIS) for Climate and Disaster Risk Vulnerability Reduction was conducted by the Department on the Interior and Local Government (DILG) Region 13 (Caraga) for 18 local government units in the region.

The activity was held in two batches, the first was held on August 12-14, 2015 while the second was on 17-19, 2015 at August Almont Inland Hotel, Butuan City.

The participants were coming from municipalities of Surigao del Norte, Surigao del Sur and Dinagat Islands which are located along the eastern seaboard and others



that are highly vulnerable to disasters.

The main objective of the training was to train remaining highly vulnerable coastal LGUs to develop a local geographic information system which they can use to enhance their disaster preparedness response capacity, specifically, produce respective geographical hazard maps towards better decision-making on local development planning and disaster mitigation.

DILG 13 assists 7 LGUs on Business Plan Development

Seven LGUs were trained on the Development and Formulation of Business Plan held last September 15-17, 2015 at Balanghai Hotel and Convention Center, Brgy. Doongan, Butuan City.

There seven target LGUs were: a) Surigao City, Surigao del Norte; b) Municipality of Socorro, Surigao del Norte; c) Municipality of Sta. Monica, Surigao del Norte; d) Municipality of Hinatuan, Surigao del Sur; e) Municipality of Trento, Agusan del Sur; f) Municipality of San Francisco, Agusan del Sur; and Municipality of Veruela, Agusan del Sur.

The activity is under the Building Business-Friendly and Competitive LGUs (BBFCL) Program of the Department, which is aimed to capacitate local governments on the

preparation / formulation of their LGU Business Plan. The training sought to help the LGUs draw their investment road map and plan for the development of their economy.

The target LGUs were assisted in the identification of critical investments and business opportunities in their locality in order to attract more investments, create more employment, build partnerships with the private business sector and create economic opportunities.

The participants of the training were the DILG Provincial Focal Persons on Accelerating Investments for More Businesses in LGUs (AIM-BIZ), Municipal Local Government Operations



Board of Investments (BOI) OIC Director Lourdes Ellen N. Kionisala examined and evaluated the workshop outputs of the participants.

The LGU Business Plan is a tool to assist LGUs on how to develop, maximize, and utilize their resources for the promotion, attraction and retention of new and old investments in pushing forward for more economic growth, development and competitiveness of their LGUs economic condition.

Relative to the Advisory issued by this Department and the Department of Health dated July 9, 2015 pertaining to the 2015 Implementation of the LGU Health Scorecard, A sub-System of the Governance Performance Management System (LGPMS), this level, in coordination with the DOH Center for Health Development -Caraga, conducted the LGU Health Scorecard Validation Conference on September 8-9, 2015 at Hotel Luciana, Butuan City.

The activity is in line with Steps 5 and 6 as per implementation process from the same Joint

Advisory, on the Data Review, Reconciliation and Certification Stage and Data Aggregation at the Provincial Level. The expected/ projected timeline of which is on Aug. 13-Sept. 4 and Sept. 7-11, respectively.

The target participants were the Provincial/City Health Officers (P/CHOs), DMO IV of DOH Provincial Offices, LGPMS Focal Persons of the DILG Provincial Offices, PHTL/DMO V of the DOH Regional Office, and technical personnel of the DILG Regional Offices. A total of 37 participants and conference staff were in attendance.

After the discussions on DILG-DOH Joint Advisory and Department DOH Memorandum No. 2014-0147 on the LGU Scorecard Guidelines and the Data Capture Form, the participants broke into groups according to province to do the data review and reconciliation which went on until the end of day 1 and on day 2 continued with the workshop on the provincial data aggregation. Finally, action plans were asked from each province to lay down the next steps and timelines they need to follow to be in sync or catch-up with the national

"We are now ready to conduct coaching session with our LGUs so that they will know how to derive the accurate data and not just give figures for the sake of compliance, " said Engr. Henrito Simplicio, Sanitary Engineer of PHO of Surigao del Sur.

timeframe.

Whereas DMO Erwin Pingal, PDO Surigao del Norte,

expressed his appreciation of the activity because he realized the significance and weight of his role in certifying the forms. He can now say with confidence that their report is accurate.

From the DILG side, LGOO V Shiela Gesta, LGPMS Focal Person of DILG Surigao del Norte was thankful that the activity was conducted so that they can level-off understanding in terms of the DCF indicators and hopes that next time around, other LGUs and functionaries, e.g. budget officers, are included in the orientation.

PAMANA'S Battle Against Poverty

In 2012, 78.57% of the PAMANA was granted to Siargao Island in the amount of Php 7 million for livelihood projects. The project entitled: "Integrated High Value Crops Production and Mangrove Protection with Livelihood" was intended to provide livelihood for its recipients. It was implemented by the Provincial Government of Surigao del Norte under the Provincial Agriculture Office (PAO).

Siargao Island of the Province of Surigao del Norte is not a conflict-affected area nor a CNN influenced area but the place is battling/fighting/struggling/striving/combating a different kind of conflict, which is the "Battle Against Hunger."

Poverty makes the island of Siargao susceptible and vulnerable to insurgent activities, which qualifies it to be a recipient of the PAMANA program.

The livelihood projects under the PAMANA grant included crop production, mariculture development, livestock production, mangrove production with livelihood and trainings for the program beneficiaries.

During implementation, there were challenges hurdled and a few roadblocks encountered, but the eagerness of the community and the persistence of the project implementer (PAO) made a break-through to finally reap the harvest of what they sow.

Since 2012, the recipients were still able to sustain the projects as they are continuing to receive the benefits.

In fact, Mr. Regen Porta of Brgy. San Roque, Pilar, Surigao del Norte, one of the recipient of the vegetable production livelihood testified that out of his income from the squash production, he was able to buy a carabao.

Ms. Siony lara of San Isidro and Ms. Angelina Pejir of Del Carmen, Surigao del Norte expressed their gratitude to the PAMANA project because out of the earnings from the vegetable production, they were able to address the educational needs of their children and at the same time, meet the demands of their family expenses.

The gains and benefits that the recipients received from the livelihood project were indeed life -changing. It has not only provided additional source of income for the recipients but at the same time taught them agricultural technologies to improve farm produce.

Forty (40%) percent of the livelihood project was devoted to crop production. The farm production includes vegetables, corn, watermelon, papaya, pineapple, calamansi, legumes and banana.

The vegetable production was planted in 23 sites in the island, the banana in ten (10) sites.





Mariculture development included seaweed production and nerserying, abalone production, crab pot and fattening and fish pot. Seaweed production received the biggest budget amounting to Php 750,000.00 followed by abalone and crab fattening.

Goat raising is the main livestock project in the island. For the mangrove protection with ecotourism activity project in the Municipality of Socorro, pump boats with fishing nets were provided to the recipients.

Trainings to support the different livelihood undertakings in Siargao were conducted, such as Organic Fertilizer Production and Goat Raising.

To this day, the PAMANA project has undeniably made a positive change in the lives of the recipients.

The PAMANA Program is a manifestation that our government reaches out to its people in need.

The Regional Peace and Order Council (RPOC) of Caraga exerts efforts in handling internal displacement brough about by legitimate armed conflict as issues of insurgencies and criminality is affecting the region.

In order for RPOC to appropriately address the internal displacement incidents, the Committee on IPD Matters was created 2012 to oversee displacement matters in the LGUs.

The formulation of the handbook in handling internal displacement is defined in the Caraga Roadmap for Peace, which the RPOC intends to establish protocols in handling internal displacement that will aid stakeholders particularly Local Peace and Order Councils (LPOCs). This is to ensure appropriate treatment and action that will outline mechanisms and strategies in dealing with situations of the IDPs.

DILG releases PhP57.8 Million PAMANA checks to SDS. ADS

The Department of the Interior and Local Government (DILG) Caraga awarded Php57.8Million worth of checks to two recipient provinces in the region, Agusan del Sur and Surigao del Sur, to implement the Payapa at Masaganang Pamayanan (PAMANA) projects under DILG fund during the Regional Peace and Order Council (RPOC) Second Quarterly Meeting last June 30, 2015 at Mazaua Island Resort, this city.

Awarding of checks was headed by DILG Regional Director Lilibeth A. Famacion joined by RPOC Chair and Butuan City Mayor Ferdinand M. Amante Jr., PSSupt Pedro U Obaldo of Police Regional Office (PRO) XIII, and MGen Oscar T Lactao of 4th Infantry Division of the Philippine Army. The checks released are the first tranches equivalent to 80% of each project's cost.

Provincial Administrator Efren Rivas of Surigao del Sur received Php33.8Million worth of checks for the province which will fund four (4) different infrastructure projects, namely: Construction of Carromata to Bitaugan Road Opening (30kms) Phase II in San Miguel amounting to Php24Million; Rehabilitation of Union-Dogak-Rajah Cabungsuan Road Phase IV in Lingig amounting to Php1.8Million; Road Opening of barangay proper to Camunohan, Bayogo Phase II in Madrid amounting to Php4Million; and Construction of 15LM Single Lane Flat Slab Bridge II, Bayogo Phase II in Madrid amounting to Php4Million.

Provincial Governor Adolph Edward G. Plaza also received the check amounting to Php24Million awarded to the Province of Agusan del Sur for the Construction of Bridge Approaches in Sta. Irene-La Purisima Bridge in Prosperidad. He also received the Performance Challenge Fund (PCF) 2014 check of Php7Million for the improvement of D.O Plaza Memorial Hospital in his province.

The first activity was done last August 11-12, 2015that began the series of activities for the formulation of the POC Handbook. The second Consultative Workshop was done last September 28-29, 2015 attended by composite members of the RPOC Committee on IDP Matters. During the 2nd Consultative Workshop, LGOO VIII Charissa T. Guerta led the writeshop.



LEGALLY SPEAKING...

Appointment of Provincial Administrator

The Provincial Prosecutor's Office of one Province in the region, asked of the same question wrote a letter-query to this Office relative to the appointment of their Provincial Administrator, Mr. XXX, which was invalidated by the Civil Service Commission, who previously validated the appointment of this same person in the same position during the past administrations.

QUERY:

Is CSC the proper agency to implement the provisions of the Local Government Code, particularly, in this case, Section 480 thereof?

OPINION (Regional Legal Opinion 2015-009):

Yes. Under Executive Order 292, the Civil Service Commission shall have the following functions:

XXX

<u>Declare positions</u> in the Civil Service as may properly be <u>primarily confidential</u>, <u>highly technical or policy determining</u>;

XXX

<u>Take appropriate actions on all appointments</u> and other personnel matters in the Civil Service including extension of service beyond retirement age;

In Civil Service Resolution No. 001156 dated May 12, 2000 entitled Carmencita O. Reyes re Appointment; Provincial Administrator, the Commission, declared:

The "position of Administrator (Provincial, City of Municipal) as primarily confidential in nature, and the term of office of appointees to said positions, consistent with the LGC, to be coterminous with the officials they serve."

The same Resolution quoted Senator Aquilino Pimentel, Jr., the principal author of Republic Act No. 7160, in a commentary contained in his book "The Local Government Code of 1991: Key to National Development," (p.514) statement, as follows:

"1. Officials Subject to Local Government Appointment and Exceptions. This Title (Title Five) lists some 22 officials for every municipality, city and province whose appointments, with three exceptions, are lodged with municipal mayors, city mayors and the provincial governor respectively: They are all career officials except the Legal Officer, Information Officer and the Administrator whose terms of office are co-terminous with the mayor or the governor who appointed them."

The Supreme Court en banc in G.R. No. 185740 dated July 23, 2013 entitled the Provincial Government of Camarines Norte vs. Beatriz O. Gonzales categorically stated that:

"R.A. No. 7160 made the provincial administrator position coterminous with its appointing authority, reclassifying it as a non-career service position that is primarily confidential."

Finally, for the proper recourse in Non-Disciplinary Cases, such as Invalidation or Disapproval or Appointment, we invite your attention to Rule 16 of the Revised Rules in Administrative Cases in the Civil Service (RRACCS).

BOTTOM-UP_BUDGETING

Road to Wadas.

The road to Wadas in the Municipality of Dinagat was rough and rocky with lots of deep holes and patches of large rocks. For a long time, people were complaining because this road is the shorter way to the trading center to San Jose and because of this, they could not easily transport their fish catch and farm products.

*In 2013, the Municipality through the Civil Society Organizations (CSOs) pro*posed for the funding of the 1 km. road concreting worth PhP 900,000.00 in their Local Poverty Reduction Action Plan (LPRAP) for funding by the Bottom-up Budgeting (BuB). The project was intended to facilitate the easy access of the farmers and fisher folks in transporting their products to the larger trading centers in the province.



Children in the neighborhood were very happy playing at the crossroad of the newly constructed road from the housing settlement to the main road to San Jose.

In April 2015, the project was fully completed. The participation of the people in providing some of the labor and their constant cooperation contributed to its smooth implementation and finally, to its completion.

When asked about the new road constructed, one fisherman claimed "...nalipay ug kontento gyud me diri sa improvement sa karsada nga buhat sa BUB kay sukad pa kaniadto, mao gyud ni problema sa mga bata padulong sa eskwelahan ug sa amo nga magdala sa mga isda padulong sa San Jose. " In fact, the people confirmed satisfaction about the Project.

When the children were asked how they felt about the road improvement, they joyfully showed how they can play, ride and walk to and from school everyday.

One child contended "nalipay mi kay kaniadto, kung dili lapokbatohon nga lisud mi makaagi. Karon, sayon ra kayo maglakaw ug way delikado..."

Riding back home was already possible compared to the previously very rough and bumpy road to Wadas.

Indeed, the children were satisfied with the new road improvement.

Site Validation for CSO Accreditation conducted

Cooperative (WAMPCO).

The accreditation was conducted through site inspection and evaluation of documents. There were also interviews with the target beneficiaries of the training programs which they have already implement-

The CSO Training Programs were evaluated on the areas of (1) Formal Linkages; (2) Organization and Management Structures, (3) Training Program for CSOs, (4) Training Materials, (5) Assets, Physical Facilities, and Equipment, and (6) Pool of Resource Persons.


Participatory games were likewise done to effectively impart to the participants on what should be their role in program/project implementation.
