Approved Budget for the Contract: One Hundred Forty One Thousand Six Hundred Sixty Nine and 14/100 Pesos (Php141,669.14); Contract Duration : 30 days from receipt of Purchase Order.

Prospective bidders shall accomplish, provide correct and accurate information and submit Price Quotation Form duly signed by the authorized signatory (Annex "A")

Submission shall be not later than 9:00 a.m. on **JUN 07 2013** Open quotations may be submitted, manually or through facsimile at DILG Regional Office 13, Libertad, Butuan City, Tele/Fax No. 342-2134 or 815-1299.

Price quotation/s must be valid for a period of thirty (30) calendar days from the date of submission. Award of contract shall be made to the total lowest quotation which complies with the minimum technical specifications and other terms and conditions stated herein.

The DILG 13 shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.

Any alterations, erasures or overwriting shall be valid only if they are signed or initialed by the bidder or his/her duly authorized representative/s.

Liquidated damages equivalent to one tenth of one percent (0.001%) of the value of the deliverables not delivered within the prescribed period shall be imposed per day of delay.

The DILG 13 shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
