BAC Resolution Recommending Award No. 2018 July 24, 2018

RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD FOR THE MEALS AND ACCOMMODATION FOR THE CONDUCT OF THE REGIONWIDE ROLL-OUT OF TRAINING AND ORIENTATION OF THE GUIDELINES ON THE FUNCTIONALITY OF ADAC, IDMRIS, ADAC-RD, AND PERFORMANCE AUDIT OF ADAC's ON AUGUST 1-3, 2018 AT THE CONTRACT PRICE OF PhP859,600.00

WHEREAS, the Department of the Interior and Local Government Regional Office XIII has an approved budget for the contract of Eight Hundred Eighty Six Thousand Seven Hundred Pesos (Php886,700.00) for the above activity;

WHEREAS, upon request of the conduct of the activity, the BAC posted in the PHILGEPS, agency website and bulletin board the Request for Quotation for the activity;

WHEREAS, in response to the request, the following service providers submitted their quotations as follows Butuan Grand Palace Hotel Php859,600.00, Almont Inland Hotel Php1,001,800.00, Hotel Oazis Php862,700.00;

WHEREAS, the BAC declared Hotel Oazis and Almont Inland Hotel disqualified due to unresponsive quotation;

WHEREAS, the BAC declared Butuan Grand Palace Hotel to have given the Lowest Calculated and Responsive Quotation most advantageous to the government;

WHEREAS, upon unanimous vote, the BAC hereby recommends to Ms. Lilibeth A. Famacion, Regional Director, Head of the Procuring Entity, to award the above contract to Butuan Grand Palace Hotel and issue the corresponding Notice of Award.
