Subject personnel shall clear herself of any property and financial accountabilities in her present station and report to her new assignment accordingly.

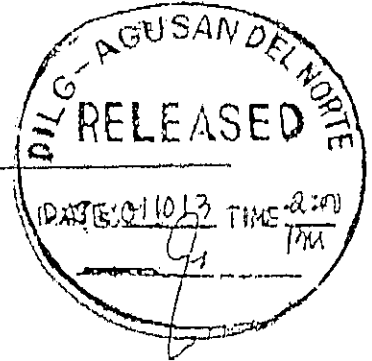


SUBJECT : REASSIGNMENT OF PERSONNEL
