

I. Regional Peace and Order Context

Region XIII – Caraga is located at the Northeastern part of Mindanao. It is one of the newly created regions in the Philippines.

It is composed of five provinces, six cities, and 67 municipalities. Its beauty, potentials, and richness are seen side by side with the contradicting poverty of its people. It is a region peopled by Christians, Muslims, and indigenous peoples. Unfortunately, its natural bounty and rich cultural diversity have also been sources of conflict among contending groups. Areas in the region have been the site of violent clashes between the government and other armed entities for a number of years.



While generally peaceful, Caraga Region is continually haunted by internal displacement, which occurs almost every year on different scales. Internal Displacement in the Region is mostly caused by armed conflict involving between and among state and non-state actors and oftentimes with participation of the members of indigenous people's communities who are sympathetic to either side. In most cases, internally displaced persons are the vulnerable tribal communities who are trapped in the skirmishes between the government and the insurgents and even lawless elements like the

New People's Army (NPA) and other Communist Terrorist Groups (CTGs)

Caraga is a region prone to geological and meteorological or hydrological hazards. Flooding occurs frequently. It experiences frequent flooding (flashfloods) and landslide incidents along with typhoons and earthquake. This condition heightens the risk of displacement for the Region due to natural causes.

Established to ensure peace and order and public safety, build and sustain empowered and resilient communities in Caraga, the Regional Peace and Order Council of Region XIII – Caraga has been firm in its commitment to achieve a lasting peace.

Pursuant to RPOC Resolutions Reorganizing the Regional Peace and Order Council (RPOC) Caraga, RPOC Caraga is under the dynamic and strong leadership of Hon. Alexander T. Pimentel, Governor of the Province of Surigao del Sur with MGEN ANDRES C. CENTINO, Division Commander - 4th Infantry Division, Philippine Army and the recently installed PBGEN ROMEO M CARAMAT JR, as Co- Vice Chairpersons.

II. Organization

4) Civil Society Organization (CSO) Membership to RPOC





2) Task Force Balik-Loob Enhanced Comprehensive Local Integration Program Awarding of Assistance to Former Rebels (FRs) and Interfacing of RTF-ELCAC and RTF COVID-19 One Caraga Shield with the Department Secretaries on December 22, 2020



To award government assistance to the former rebels who surrendered to return to the folds of the law and to discuss the COVID-19 situation in the region and how the regional government can strategically move forward, the Secretary of the Interior and Local Government Eduardo M. Año, the Secretary of Health Francisco T. Duque III, the Secretary of National Defense Delfin N. Lorenzana, and the Presidential Adviser on the Peace Process Secretary Carlito G. Galvez, Jr., visited Caraga for an interfacing activity with the region's Local Chief Executives and RTF-ELCAC and RTF COVID-19 One Caraga Shield members on December 22, 2020 in Almont Inland Hotel, Butuan City.

There were twenty-six (26) Former Rebels (FRs) in the Province of Agusan del Norte and seven (7) FRs in Butuan City that were awarded with assistance. The activity also provided an avenue for the key officials of the national government to interface with the key

officials of the regional government in making sure that Caraga will keep on making headway in ending local communist armed conflict and the COVID-19 pandemic.

3) Successful Launching of the Home Defense Village (HDV)



The Home Defense Village at Sitio Amongon, Barangay Noli, Bayugan City, Agusan del Sur was successfully launched on June 30, 2020 with a total of 8.98 hectares to be distributed to the families of 30 Former Rebels.

This project aims to protect the Former Rebels in returning to society and support their livelihood thru agriculture. By creating their own tribal community they can support each other and protect themselves from the CTG's with the support of the PNP, AFP and LGUs.

The Home Defense Village will provide them with land, homes, electricity, water and livelihood support for a long lasting and sustainable life of peace.





A Regional Border Quarantine Control Checkpoint has been established for the region. This is put the regional borders on lockdown to prevent transmission of COVID-19 from our high-risk neighboring regions. The regional borders were manned by a Composite Team from the Philippine National Police (PNP) XIII, Armed Forces of the Philippines (AFP), LGU Personnel from DRRM Office and Health Office and the Bureau of Fire Protection (BFP).

6) Management of Locally Stranded Individuals and Returning Filipino Overseas (LSIs & ROFs)

RPOC has provided support to the Management of LSIs and ROFs to the region. To augment the operations in the management of the stranded individuals, the LGUs (five provinces and one HUC) committed contribute have to PhP100,000 each to support the logistical needs and resource requirements. In addition. the five (5)provincial governments and the City Government of Butuan have proactively contributed PhP

300,000 each to assist in the operational expenses that go along maintaining the regional border checkpoints, which include putting up makeshift bunk houses for those manning the checkpoints.

7) Enhanced Comprehensive Local Integration Progam (E-CLIP)



Caraga recognizes that the call for peace, security, and order is not solely the work of the military. With the most recent developments in addressing the issues with rebels, President Rodrigo Duterte signed the Administrative Order No. 10 institutionalizing the Enhanced Comprehensive Local Integration Program or ECLIP. This is a government program that aims to help the rebel members of CPP-NPA-NDF and Militia ng Bayan to restore their allegiance to the Philippine government. Through this program, they can be reintegrated back to the community, be with their families, and start over with their new, normal lives.





9) Data on Quarantine Violations

As of January 19, 2021, there has been a total of 1,819 individuals who violated Curfew Hours, while 9,562 persons were arrested for Disobedience to an agent of a Person in Authority, 6,437 violations on not wearing of face mask and 866 individuals who violated Social Distancing, with a total of 18,684 violators.



10) PNP Anti-Terrorism Accomplishments

A total of 556 CPP-NPA-Terrorist members were neutralized, most of them have surrendered including 40 PSR listed and 377 Non-PSR listed. As a result of these operations, 263 firearms were recovered/surrendered.



On December 26, 2020, 32 Communist Terrorist Group members surrender during 52nd CPP Anniversary. Among the firearms they brought were: 1 Sub Machine Gun, 1 M14 rifle, 11 Shotguns and 6 Pistols. They also pledged their



loyalty to the Philippine Flag, burned CTG flags and signed a manifesto of support to the Anti-Terrorism Act.

13) Accomplishment on the War Against Illegal Drugs

For CY 2020, a total of 333 operations were conducted against illegal drugs that resulted in the arrest of 357 illegal drug personalities and the death of three (3) individuals after choosing to engage our police officers in a firefight. The estimated Dangerous Drug Board value of the confiscated illegal drugs amounted to more than 10 million pesos.



14) Status of Drug Affectation

In the implementation of the Barangay Drug Clearing Program (BDCP), the Provinces of Agusan del Norte, Agusan del Sur, Dinagat Islands and Surigao del Sur were declared as Drug-Cleared.

15) Arrest of Wanted Persons

From September 17 to November 17, 2020, a total of 527 wanted persons were arrested, including 102 Most Wanted Persons (Manhunt Charlie/ EMPO target) and 425 other wanted persons.



16) Accomplishment on Loose Firearms

On the Campaign on Loose Firearms, a total of 358 operations were conducted against Loose Firearms and 247 arrested personalities. Of the 1,051 loose firearms, 172 were turned-in to our police units.



17) Handbook in Handling Internal Displacement

The Handbook in Handling Internal Displacement was finalized through the inputs, comments and recommendations the by members of the Regional Peace and Order Council. Its approval and adoption by Council is set for the 3rd Quarter, CY 2020 RPOC meeting. It is for the following purpose:



- Focused on situations, particularly armed conflict that would lead to displacement;
- Provide guidance to LPOCs in handling IDP situations; and
- Prevent displacement and identify measures in addressing the situation with durable solutions.

It was adopted by RPOC through RPOC Resolution No. 8 entitled: "A Resolution Adopting the Handbook in Handling Conflict-Induced Internal Displacement".

Remarks: This is for further discussion with AFP / PA based on their experience as to the IDPs in the Province of Surigao del Sur.

18) Caraga Peace and Development Zones (PDZs)

Ideation Workshop was conducted last December 16, 202 to gather ideas and images to discern on the Peace and Development Zones (PDZ) Concept.

This is the 3rd Ideation Work shop in CY 2020. Through GIZ, the activity will collectivize the ideas of the DILG Field Officers in order to arrive at common understanding of PDZ.



19) Closure of the TRIFPPS and ALCADEV Schools in Surigao del Sur




20) Operational Accomplishments of the Armed Forces of the Philippines (AFP)

This is the new area of operations of 4ID w/ 4 brigades, and units from the Philippine Air Force and the Philippine Navy.




There are now 3 brigades that are covering the AOR of 4ID in the CARAGA Region headed by MGEN Andres C. Centino, Division Commander of 4th Infantry Division.





In ending in ending local communist armed conflict in the JTF's AOR, the Philippine Army is clear that it needs to destroy the CTG armed groups and stop their resource generation.

Unlike the campaigns before, the JTF gives premium on simultaneously addressing CTG resource generation along with the destroying of the armed groups, otherwise no matter how much we tactically reducing enemy in numbers, they still stand to recover because they have so much resources.



With such, the command adopts the National Task Force ELCAC's Shape-Clear-Transform-Sustain (SCTS) approach as the overarching framework and laying down therein the two (2) operational methodologies, namely the Dislocate-Isolate-Disintegrate-Destroy methodology to clear focus areas of affectation and dismantling of the CTG's armed groups, and the Profile-Expose-Neutralize methodology to address the CTG support structure in order to stop their resource generation. The former we can do by ourselves, however, the latter we have to do with heavy coordination with the Task Force-ELCAC through the peace, law enforcement, and development support cluster, or PLEDS.

21) Reduction of CTGs' Strength and Firearms

In reducing the CTGs' strength & firearms in Caraga Region for the period of 01 January to December 2020. A total of 192 - NPAs, 364 - Militia Ng Bayan members, 76 HPFAs, 99 LPFAs and 749 supporters have been neutralized by the 4th Infantry Division.
