**A RESOLUTION SUPPORTING THE SUSTAINABILITY OF THE  
“ENDING LOCAL COMMUNIST ARMED CONFLICT” (ELCAC)  
FUNDS**

**WHEREAS**, Executive Order No. 70, Series of 2018 entitled: “Institutionalizing The Whole-Of-Nation approach in Attaining Inclusive and Sustainable Peace, Creating a National Task Force to End Local Communist Armed Conflict (ELCAC), and Directing the Adoption of a National Peace Framework” was issued by President Rodrigo Roa Duterte to address the root causes of insurgencies, internal disturbances and tensions, and other armed conflicts and threats;

**WHEREAS**, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2019-200 dated November 22, 2019 entitled: “Declaration to Condemn all Forms of Atrocities and Acts of Violence” encouraging the full participation and support of all Local Government Units (LGUs) to the implementation of EO No. 70;

**WHEREAS**, DILG MC No. 2019-200 enjoined all LGUs to implement the activities related to EO No. 70 by issuing a strong declaration in a form of a Resolution that may be issued by respective Sanggunians condemning all forms of atrocities and acts of terror and violence that may jeopardize the safety of the people and prejudice the economic and social development of their communities;

**RPOC XIII (Caraga)**

**WHEREAS**, DILG MC No. 2019-200 also encouraged all LGUs to allocate appropriate funding to support and sustain the programs and activities of LGUs on EO No. 70 in order to usher genuine positive peace through local inclusive development;

**WHEREAS**, consistent with the thrusts and priorities of the national government with the application of the “Whole-of-Nation” approach, the root causes of insurgencies, internal disturbances and tensions, and other armed conflicts and threats will be addressed through EO No. 70;

**WHEREAS**, DILG issued a Memorandum dated April 28, 2021 enjoining Sub-National Peace and Order Council (POCs) to Issue a Resolution Supporting the Sustainability of the Ending Local Communist Armed Conflict (ELCAC) Funds;

**NOW, THEREFORE, BE IT RESOLVED, AS IT HEREBY RESOLVED**, the Regional Peace and Order Council (RPOC) XIII – Caraga hereby unanimously agrees to support the sustainability of the “Ending Local Communist Armed Conflict” (ELCAC) Funds;

**RESOLVED FURTHER**, that a copy of this RPOC XIII – Caraga Resolution be furnished to the National Peace and Order Council (NPOC), National Task Force - End Local Communist Armed Conflict (NTF-ELCAC), Regional Peace and Order Council (RPOC) Members, Regional Development Council (RDC) Members, Regional Task Force - End Local Communist Armed Conflict (RTF-ELCAC), Cabinet Officer for Regional Development and Security (CORDS), Caraga Congresspersons, Local Government Units (LGUs), Caraga Business Chamber of Commerce, and private sector in the region for information and reference;

**RESOLVED FURTHERMORE**, all Local Government Units (LGUs) shall

**RPOC XIII (Caraga)**

issue a Resolution through their Local Peace and Order Councils (LPOCs) supporting the sustainability of the “Ending Local Communist Armed Conflict” (ELCAC) Funds;






