A RESOLUTION INSTITUTING THE SCHEDULE OF RPOC XIII – CARAGA QUARTERLY MEETINGS

WHEREAS, Republic Act No. 7160 or the Local Government Code of 1991 particularly Section 16 mandates all local government units (LGUs) to ensure and maintain peace and order within their respective areas of jurisdiction, among other concerns;

WHEREAS, Section 116 of R.A. No. 7160 states that a Peace and Order Council (POC) shall be established in every Province, City and Municipality;

WHEREAS, Executive Order No. 773 series of 2009, entitled "Further Reorganizing the Peace and Order Council", further reiterated in DILG Memorandum Circular No. 2019-143, dated August 27, 2019, or the Omnibus Guidelines for Peace and Order Councils (POCs), provides for the reorganization of Peace and Order Councils, its composition and duties and functions;

WHEREAS, as the primary council mandated to provide a forum of inter-disciplinary dialogue and deliberation of major issues and concerns affecting peace and order and public safety within their respective areas of jurisdiction, the Regional Peace and Order Council (RPOC) plays a significant role in harmonizing peace and development programs and policies through the implementation of a strategic and comprehensive plan, capacity building and strengthening linkages with the local peace and order councils and other mandated institutions;

WHEREAS, to convene the members of the Regional Peace and Order Council (RPOC) XIII – Caraga, a quarterly meeting shall be scheduled pursuant to Section 5.2.2 of DILG Memorandum Circular No. 2019-143;

NOW, THEREFORE, BE IT RESOLVED, AS IT HEREBY RESOLVED, the members of the Regional Peace and Order Council (RPOC) XIII – Caraga unanimously agree to conduct its quarterly meeting every Wednesday of the 1st week of the last month every quarter of CY 2021.

RESOLVED FURTHER, that a copy of this Resolution shall be furnished to all members of RPOC for their information and guidance.
