**WHEREAS**, the Boy Scouts of the Philippines (BSP) has the Mission to help the youth develop values and acquire competencies to become responsible citizens and capable leaders anchored on the Scout Oath and Law;

**WHEREAS**, the BSP National Office issued National Office Memorandum No. 32, Series of 2021 with the subject: “Nominees for Regular Board Members of the National Executive Board” with eleven (11) nominees to include Hon. Dale B. Corvera, Governor of the Province of Agusan del Norte;

**WHEREAS**, Hon. Dale B. Corvera was elected as a Regular Board Member of the National Executive Board of the Boy Scout of the Philippines (BSP) and consequently as the National President during the BSP’s Online 64<sup>th</sup> Annual National Council Meeting held in May;

**WHEREAS**, Hon. Dale B. Corvera served as International Commissioner of the BSP from 2002 until June 21, 2021, when he was elected to the board and also an elected member of the World Organization of Scout Movement-Asia Pacific Region Scout Committee;

**NOW, THEREFORE, BE IT RESOLVED, AS IT HEREBY RESOLVED**, the Regional Peace and Order Council (RPOC) XIII – Caraga upon the motion of Ms. Lilibeth A. Famacion, CESO III, Regional Director of the Department of the Interior and Local Government (DILG) XIII as severally seconded, hereby adopts a Resolution Commending Hon. Dale B. Corvera, Governor of the Province of Agusan del Norte as the New National President of the Boy Scout of the Philippines;


